Buyers Responsibilities

The \$500.00 deposit is nonrefundable.

Have puppy examined by a licensed veterinarian within 72 hours of it going home, holiday weekends being an exception. The seller must be informed of the results of the vet check, whether good or bad, by midnight on the same day either by email or phone message. If the buyer fails to do this, the contract becomes null/void.

Puppy must be provided with preventative care including (but not limited to) annual vet exams, following vet guidelines on deworming, vaccinations, and heartworm prevention. The puppy must also be housed and cared for properly and fed a premium dog food.

Health Guarantee

Breeder has taken every reasonable precaution to ensure that this puppy is healthy at the time of sale. The puppy has received age-appropriate veterinary care and is believed to be in good health to the best of the Breeder's knowledge at the time of transfer.

Due to the Breeder's retirement and the discontinuation of future litters, a one-year replacement health guarantee is no longer offered. Buyer understands and agrees that no replacement puppy will be provided under any circumstance.

Buyer acknowledges that, to date, Breeder has not had any instance in over 10 years of breeding where a puppy required replacement due to a genetic or health related issue. While this reflects the quality and care of the breeding program, no guarantees can be made regarding the future health of any living animal.

While the Breeder can no longer provide replacement guarantee, Breeder does offer guidance on securing pet insurance for your new puppy. Pet insurance can provide peace of mind and financial protection should unexpected health concerns arise. If you feel at all uncertain, Breeder strongly encourages you to explore and purchase a policy that fits your needs and comfort level. The Breeder has partnered with Trupanion who offers the first 30 days free.

As of the date of delivery, your puppy will be up to date on vaccinations and de-worming. Treatment/preventative for coccidia and giardia will also be given. The buyer will be given a shot record with everything that has been given. More vaccinations and de-wormings will be needed and buyer is responsible for these. The puppy is guaranteed against Parvovirus and Distemper for 5 days upon arriving to buyers home. If the buyer claims either of these diseases an ELISA test must be performed within 5 days. This guarantee does not include stress induced illness such as coccidia or kennel cough, which can be very common in puppies.

The Breeder has made a reasonable judgement regarding the eventual adult coat of the puppy, as well as an estimated adult weight and size. However, as these are living beings, this judgement does not guarantee the eventual coat type or size of the dog, nor is there a guarantee of the eventual allergy-friendliness, degree of shedding or color of the coat as the puppy is growing up or at maturity.

Buyer understands that puppy behavior can change over time and that successful integration into the Buyers home requires ongoing socialization , training , and consistent management. Negative behavior is not covered.

The seller is not responsible for any medical expenses that are incurred. By owning a puppy trips to the vet and bills are expected. The puppy has been vet checked within 5 to 7 days of leaving the seller and found to be in good health. The puppy will not leave if it is showing any sign of illness or injury.

If the terms of this contract are not met it becomes null and void. By not signing the contract the buyer will be purchasing the puppy AS IS with no guarantee or warranty. This contract is only good for the original buyer and is not transferable. This is the only guarantee set forth, no other warranties either expressed or implied. Should the buyer choose to pursue matter in the court of law, that place of jurisdiction is Lee County, Iowa. The buyer will also be responsible for any attorney fees that the seller incurs.
